

Affiliate Program Terms and Conditions

These terms and conditions outline the agreement between Ambassadoribet and you for participation in our affiliate program. By signing up as an affiliate, you acknowledge that you have read, understood, and agreed to these Terms. Please review them carefully before proceeding.

Affiliate Sign-Up and Qualification

1.1. To be eligible for the Program, the Affiliate must complete the sign-up process and agree to these Terms.

1.2. The Affiliate must comply with all applicable laws and regulations while participating in the Program.

1.3. The Company reserves the right to reject any affiliate application at its sole discretion, without the need to provide a reason.

Deal Type One - Cost Per Acquisition (CPA)

2.1. For every new player referred by the Affiliate who deposits at least 1 EUR for the first time (FTD), the Affiliate will receive a fixed commission of 3 EUR (CPA amount).

2.2. The CPA amount will be credited to the Affiliate's account once the conditions in 2.1 are met, and the Company has verified the validity of the referral.

Deal Type Two - Net Gaming Revenue (NGR)

3.1. All players referred by the Affiliate will contribute towards the global Calculated Net Gaming Revenue (NGR).

3.2. The Calculated NGR is determined by deducting player winnings, bonuses, and chargebacks from the total revenue generated by the referred players.

3.3. If the Calculated NGR for the Affiliate is a positive number at the end of the month, the Affiliate will be eligible to receive a pre-determined percentage of their NGR as commission. The specific commission percentage will be set by the Company and communicated to the Affiliate.

3.4. If the Calculated NGR for the Affiliate is negative at the end of the month, the Affiliate will not receive any commission for that period.

3.5. At the beginning of each new month, the Calculated NGR will reset to zero, and the commission calculation will start anew.

Payment and Payouts

4.1. The Company will process affiliate payments in a timely manner, subject to any necessary verifications and fraud checks.

4.2. Payment methods, minimum payout thresholds, and other payment-related details will be provided to the Affiliate upon acceptance into the Program.

4.3. The Company reserves the right to withhold or suspend payments to the Affiliate if there is reasonable suspicion of fraudulent activity or violation of these Terms.

Promotional Activities

5.1. The Affiliate agrees to promote the Company's products responsibly and ethically.

5.2. The Affiliate shall not engage in any form of spamming, misleading advertising, or illegal marketing practices.

5.3. The Company may provide marketing materials to the Affiliate, which the Affiliate may use for promotional purposes with prior approval from the Company.

Term and Termination

6.1. These Terms will remain in effect until terminated by either party.

6.2. The Company may terminate the Affiliate's participation in the Program at any time for any reason, without the need to provide advance notice.

6.3. The Affiliate may also terminate their participation in the Program at any time by providing written notice to the Company.

Modifications

7.1. The Company reserves the right to modify, suspend, or terminate the Program and these Terms at any time, with or without notice.

7.2. Any changes to the Program or Terms will be communicated to the Affiliate, and continued participation in the Program after such changes constitute acceptance of the modified Terms.

Governing Law and Disputes

8.1. These Terms shall be governed by and construed in accordance with the laws of Georgia, without regard to its conflict of laws principles.

8.2. Any disputes arising out of or in connection with these Terms or the Program shall be subject to the exclusive jurisdiction of the courts in Georgia.
